On June 24, 2003, Mr. Imhoff acquired 418,249 shares of the Issuer as a distribution from the estate of his father, Herbert F. Imhoff. No funds were used in this acquisition. At various times prior to the distribution from the estate, Mr. Imhoff had acquired 32,800 shares at various prices. Of the 32,800 shares 17,400 are held by Mr. Imhoff's minor children and 6,700 are held by Mr. Imhoff's wife.
